TERMS AND CONDITIONS

- All permit holders must have a Valid Carp Society Membership for the length of their permit; any lapse memberships will invalidate the permit.
 - ALL LAKE RULES APPLY TO PERMIT HOLDERS – enclosed with your permit
The Carp Society reserves the right to add/amend rules at any time during the permit time; changes will be posted on the website.
 - **NEW LAKE RULE all captures 30lb must be photographed and send into the office or WhatsApp. Captures over 35lb anglers MUST call head bailiff Karl who will come to take a photo & captures over 40lb, the weight MUST be verified and photo taken by Karl.** (This is a rule and must be adhered to failure to do so will be a breach of the permit rules / terms and conditions)
 - All permit options entitle the permit holder to fish Horseshoe Lake for the validity of their permit – except during lake closures (see below t&c)
 - Non-fishing guests (partners and/or children ONLY) must hold a valid membership to accompany the permit holder (access for guests is subject to change at the discretion of the Carp Society)
 - Permits will be issued on receipt of full payment, form and photos
 - All permits are NON-TRANSFERABLE and NON-REFUNDABLE (see terms and conditions)
 - *Your details provided may be used to send promotional material relating to your permit, membership and news regarding the Carp Society; you may Opt out at any time. <http://www.thecarpsociety.com/terms-conditions/>*

KEY

Permit holders will be provided with an access card for entry to Horseshoe Lake.

All cards are individually programmed to expire when your permit runs out. Access may be temporarily blocked in the event of lake closures to manage access to the lake and reinstated when the lake is open to anglers.

Lost cards: In the event of cards being lost it is imperative that the office is notified immediately, replacement cards will be charged at £30 per card.

LAKE OR SWIM CLOSURES:

For the duration of your permit the lake or swims may be closed to facilitate Carp Society/fishing/filming events. A list of LAKE closure events will be available online/in the carp society office and may be updated throughout the period of your permit. Unplanned lake closures will be notified on the website and Facebook page.

Fish Spawning:

The lake or swims may be closed without prior notice by the Fishery Manager or Bailiff team when spawning occurs or otherwise.

Unplanned Lake Closures and Access Restrictions

All permits are personal to the named holder, non-transferable, and non-refundable. Once purchased, permits cannot be cancelled, exchanged, transferred, refunded, or credited under any circumstances. By purchasing a permit, the permit holder acknowledges that access to the fishery may be restricted or unavailable from time to time due to circumstances within or beyond the control of The Carp Society, and that the permit fee reflects this risk.

The Directors reserve the right to close the lake, restrict access, suspend fishing, or impose additional rules at any time, with or without notice, for reasons including health and safety, environmental conditions including oxygen and water quality issues, fish welfare, fishery management, maintenance, legal requirements, or any force majeure event. No refund, credit, permit extension, compensation, reduction in fees, or other reimbursement will be provided in the event of any temporary or permanent closure, restriction, suspension, or limitation of access.

Purchase of a permit constitutes acceptance of these terms.

Rule infringements: The Carp Society reserves the right to remove angler's permits and access if believed to be/caught breaching the lake rules with no liability of compensation, refunds or credit. If you have a query about any of the rules or seek clarification please contact the Carp Society office, Head Bailiff or Fishery Manager. The Carp Society reserve the right to reject an application for any reason.
